

Legal Disclaimer (Version 1.0; June 15, 2023)

This legal disclaimer ("Disclaimer") is intended to be read and understood by the customer ("Customer") in conjunction with the quotation provided by Uni-Plus ("Supplier"). By accepting the quotation, the Customer acknowledges and agrees to the following terms:

- 1. Customized, After Market, and/or Low Volume Products: The Supplier provides customized, after-market, and/or low volume products, which are specifically designed or adapted to meet the Customer's unique requirements. These products may differ from standard or mass-produced products and may have variations in design, specifications, or performance. The Customer understands and acknowledges that such products may have limited availability, and the Supplier may have certain limitations in terms of warranty, support, or replacement.
- 2. **No Warranty:** Unless explicitly stated otherwise, the Supplier does not provide any warranty, express or implied, regarding the supplied products, including but not limited to warranties of merchantability, fitness for a particular purpose, or non-infringement.
